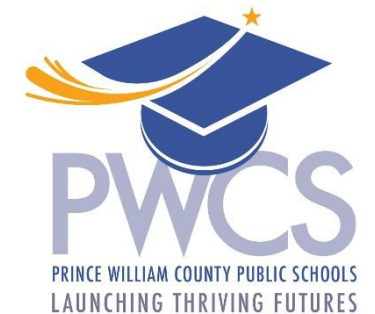

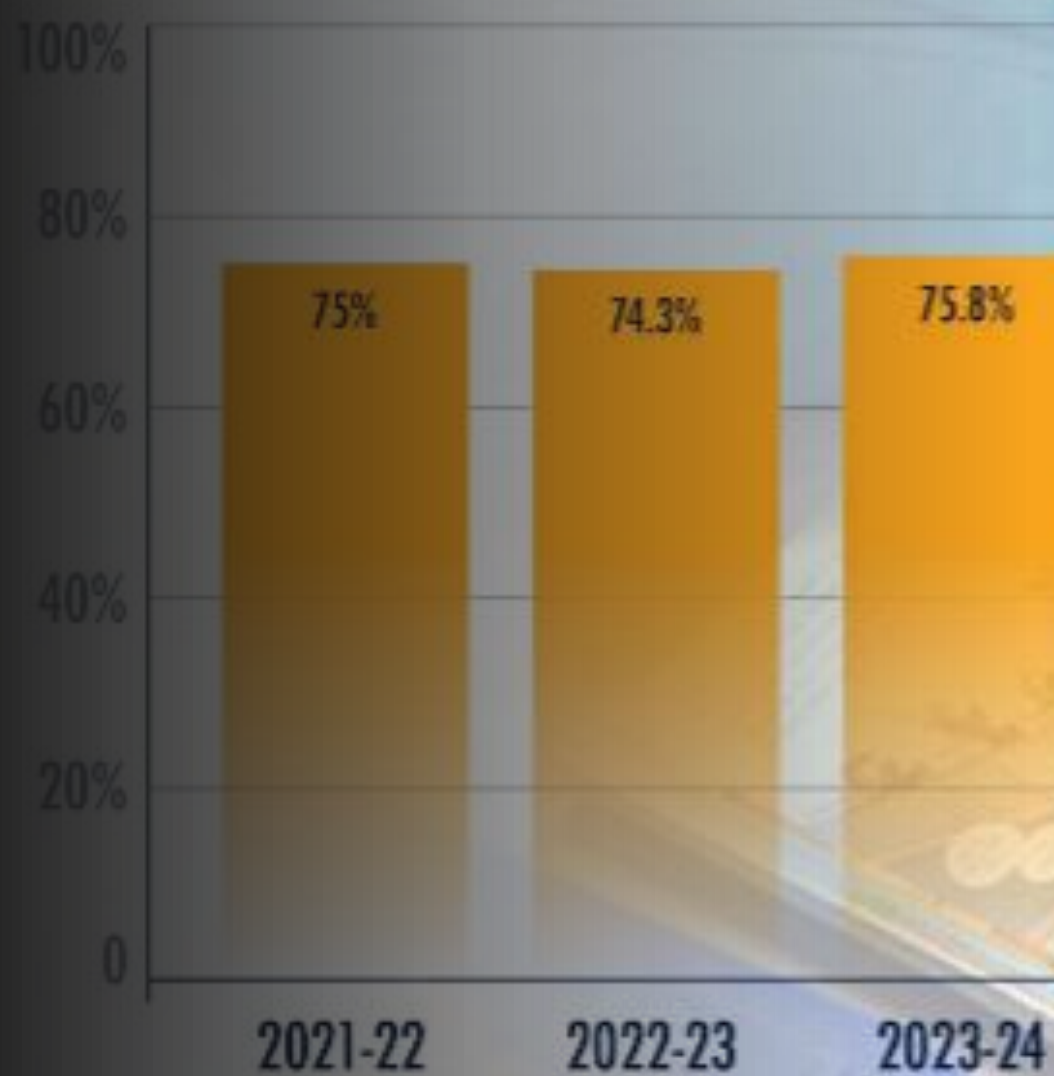


Positive Climate and Culture

 - Less than 10% of Marumsco Hills Elementary students will be considered chronically absent

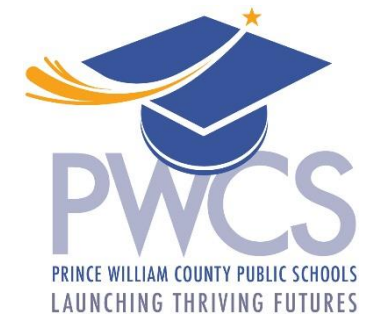


SOL: READING PASS RATES

PWCS Strategic Plan Objective: Increase student achievement in **reading**

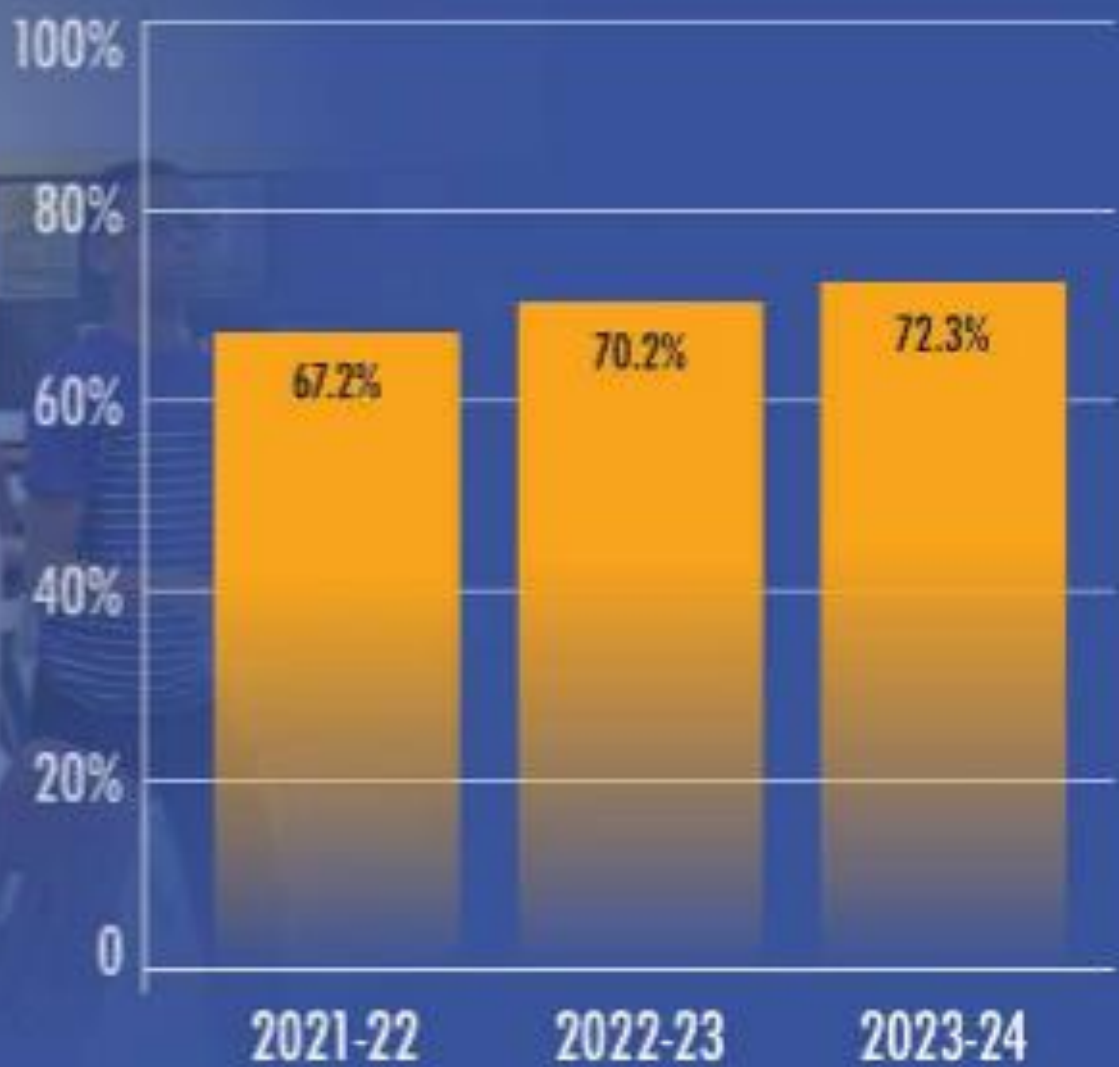
Impact Goals:

- 100% of K-3 students identified in the moderate & high-risk bands of VALLSS will have positive movement towards the low-risk band



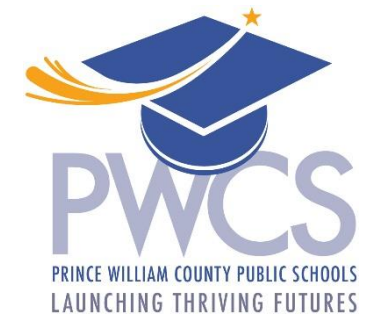


SOL: MATH PASS RATES

- 65% or more of students in grades 3-5 will score mastery and/or proficient on the math unit assessments

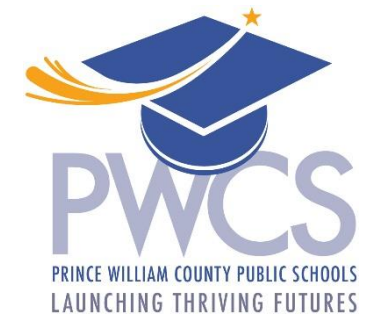

PWCS Strategic Plan Objective: Increase student achievement in **science**

Impact Goals:

- 65% or more of students in grade 5 will pass the science SOL
- 65% or more of students in grade 4-5 will score mastery and/or proficient on the science unit assessments





Three categories of schools are identified:

- Comprehensive Support & Improvement (CSI)
- Additional Targeted Support & Improvement (ATSI)
- Targeted Support and Improvement (TSI)



TARGETED SUPPORT AND IMPROVEMENT (TSI)



TSI schools are identified annually and are schools in need of support for specific student groups.

Identification Criteria:

- Schools may be either Title I or non-Title I
- Schools must have low-performing student groups (Economically Disadvantaged, English Learners, Students with Disabilities, Asian, Black, Hispanic, Multiracial, White)
- Student groups did not meet the interim measures of progress in reading and math for the previous two consecutive years and are in the lowest two quartiles for growth for one year in reading or math
